**ORDER**

As per the notification issued in the Government Order read above, sub-rule (c) of rule 23 of Part I KSR, which permitted employees to enjoy the benefit of promotions to posts not involving change of duties with all monetary benefits from the date of occurrence of vacancy, irrespective of the date of order of promotion, was deleted with effect from 1-3-2007. As the employees are denied the benefit of retrospective fixation of pay on promotion to posts which do not require assumption of charge, several service organizations have requested to restore the benefit.

2. Government have examined the matter in detail and are pleased to order that in cases of promotions which do not involve a change of duties, the promotions will have notional effect from the date of occurrence of vacancy or the date of acquiring eligibility for promotion as the case may be, but monetary benefit will be admissible only for a maximum period of one year prior to the date of order of promotion.

3. These orders will take effect from 1-3-2007.

4. Necessary modification to KSR will be issued separately.
