S. R. O. No. 452/2017.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Third Amendment) Rules, 2017.

(2) They shall be deemed to have come into force on the 1st day of February, 2016.

2. *Amendment of the Rules.*—In Part I of the Kerala Service Rules, in sub-rule (b) of rule 53,—

(a) in clause (1), for the words, letters and figures “6 per cent of the minimum of the scale of pay of the other post with effect from the 1st day of February, 2011 or the date of change over to the revised scale ordered in G. O. (P) No. 85/2011/Fin. dated the 26th February, 2011 whichever is later,” the words, letters and figures “4 per cent of the minimum of the scale of pay of other post with effect from the 1st day of February, 2016” shall be substituted;

(b) in clause (2), for the words, letters and figures “6 per cent of the minimum of the scale of pay of that post with effect from the 1st day of February, 2011 or the date of change over to the revised scale ordered in G. O. (P) No. 85/2011/Fin. dated the 26th February, 2011, whichever is later,” the words, letters and figures “4 per cent of the minimum of the scale of pay of that post with effect from the 1st day of February, 2016” shall be substituted;

(c) in clause (3), for the words, letters and figures “3 per cent of the minimum of the scale of pay of that post with effect from the 1st day of February, 2011 or the date of change over to the revised scale ordered in G. O. (P) No. 85/2011/Fin. dated the 26th February, 2011, whichever is later,” the words, letters and figures “2 per cent of the minimum of the scale of pay of that post with effect from the 1st day of February, 2016” shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The existing rates of charge allowance admissible under Rule 53 (b) of Part I, of the Kerala Service Rules to officers who are appointed to hold charge of other posts in addition to their own posts are 6 per cent for full additional charge of other posts and 3 per cent for discharging of current duties. However vide G. O. (P) No. 7/2016/Fin. dated 20th January, 2016, Government have revised the rates of charge allowance to 4 per cent for holding full additional charge and 2 per cent for discharging current duties with effect from 1st February, 2016. To give statutory validity to the said Government Order necessary amendments have to be made in rule 53 (b) of the Part I of the Kerala Service Rules.
