ORDER

As per the proceedings read first above, the following officials were provisionally promoted as Senior Superintendents / Revenue Officers. As per read 2, the currency of probation in the promoted cadre of selection post of Senior Superintendents / Revenue Officers are six months duty within a continuous period of one year, since direct recruitment is not one of the method of appointment in the selection post.
