ORDER

The Hon'ble High Court of Kerala vide judgments read above directed the Kerala Water Authority to follow the principle in the seniority list of 01.11.2000 in making further promotions. Any further temporary promotions should be only on the principle of the seniority list of 01.11.2000. In making such promotions, Rule 27 (a) and (c) of the KS&SSR have to be followed scrupulously. Hence in compliance of order a seniority list has been prepared and published vide reference read 6 and updated vide reference read 10 above. At present Fifteen posts of Assistant Engineers are vacant which are earmarked for promotion; i.e., 09 Nos. in Diploma Quota and 06 Nos. in Certificate Quota.

In the above circumstances, in addition to the transfers of Assistant Engineers listed first, with the clarification from the Legal Wing of Kerala Water Authority, the under mentioned ten senior most Draughtsman (Grade-I) are here by temporarily promoted to the post of Assistant Engineer subject to the conditions stated below in the scale of pay of ₹. 40800-85000 and posted to the places noted against their names with immediate effect.



The promotions shall be purely provisional as per prevailing rules in KS & SSR with terms and conditions stipulated in KS & SSR Part II Rule 5 Note 3 and of Rule 27, KS & SSR.

The promotions are subject to further directions of Hon'ble High Court and Govt. orders.

The promotion shall be provisional subject to such conditions.
